CONDITIONS

ENTRIES: Open at 8:00 A.M. Closes at 10:00 A.M. three (3) days before race is scheduled.

OVERNIGHT EVENTS: Entry Fee \$25. Each division will race 1 dash.

LATE CLOSER: 85th District Pace: Entry Fee \$36. This is a late closer with two legs and a final at Chillicothe going for \$2,500. Second Leg will be raced at Washington C.H. Top eight point earners will be eligible for the final—1pt per start, 50 for 1st, 25 for 2nd, 12 for 3rd, 8 for 4th, 5 for 5th place.

STAKES: Starting fee \$75.

To be raced under rules of the Ohio Fair Fund Law and conditions of the Ohio Colt Racing Association. All stake races will race only 1 heat. Equal share of purse.

MONEY DIVISION: Purse divided 50 - 25 - 12 - 8 - 5 percent all events.
